WAIVER

IN CONSIDERATION OF BEING PERMITTED TO PARTICIPATE IN ANY WAY IN THE FLORIDA TANDEM RALLY, SPONSORED BICYCLING ACTIVITIES, I FOR MYSELF, MY PERSONAL REPRESENTATIVES, ASSIGNEES, HEIRS AND NEXT OF KIN:

- 1 Acknowledge, agree and represent that I understand the nature of bicycling activities and that I am qualified to participate in such activity. I further acknowledge that the activity will be conducted over public roads and facilities open to the public during the activity and upon which the hazards of traveling are to be expected. I further agree and warrant that if at any time I believe conditions to be unsafe; I will immediately discontinue further participation in the activity.
- 2 Fully understand that (a) Bicycling activities involve risks and dangers of serious bodily injury, including permanent disability, paralysis and death (Risks): (b) these risks and dangers may be caused by my own actions, or inactions, the action or inactions of others participating in the activity, the conditions in which the activity takes place...of the negligence of the "Releases" named below: (c) there may be other risks and social or economical losses either not know to me or not readily foreseeable at this time and I fully accept and assume all risks and all responsibility for all losses, cost and damages I incur as a result of my participation in the activity.
